

# MINISTER FOR EMPLOYMENT, TRAINING AND INDUSTRIAL RELATIONS

1. TITLE: Leave Credited as Service

**2. PURPOSE:** To prescribe the entitlements for leave without pay being credited as

service for leave and salary purposes.

3. LEGISLATIVE

**PROVISION:** Section 34(2) of the *Public Service Act 1996*.

**4. APPLICATION:** This directive applies to:

public service officers; and

• temporary employees engaged under sections 112(2)(a) and 113(2)(a)

of the Public Service Act 1996; and

• employees of the Department of Health in District Health Services.

This directive does not apply to employees engaged on a casual basis under

sections 112(2)(b) and 113(2)(b) of the Public Service Act 1996.

**5. STANDARD:** The conditions prescribed in the Schedule apply.

6. EFFECTIVE

**DATE:** This directive is to operate from 1 July 1999.

**7. VARIATION:** The provisions in the Schedule may be varied in accordance with certified

agreements made under Chapter 6, Part 1 of the Industrial Relations Act 1999

or decisions of an industrial tribunal of competent jurisdiction.

8. INCONSISTENCY:

Sections 34 and 117 of the *Public Service Act 1996* and section 687 of the *Industrial Relations Act 1999* apply if there is a conflict with an act, regulation or industrial instrument.

9. SUPERSEDES: Section 23 of the Public Service Management and Employment Regulation 1988

Public Service Act 1996 shall have leave without salary credited for service for leave and salary purposes as provided in this schedule.
