SCHEDULE A

ATTENDANCE - RECORDING, REPORTING AND PUBLIC HOLIDAYS

GENERAL CONDITIONS

Records to be kept

Attendance records are to be kept on all **public service employees**.

A chief executive is to maintain a system for recording starting and ceasing times, meal breaks and absences from duty for all employees in his or her department except for those who have been, or who are of a class of office that has specifically been exempted by the chief executive.

Destruction of records

The chief executive is to keep these records for 6 years.

Reporting absences from duty

Where a public service employee is prevented, for any reason, from any reason, from any reason, we k or performing duties he or she is to report the fact to his or her immediate supervisor as poon as practicable.

If a public service employee is absent without authority, his or her in. her' te supervisor is to report the fact to the chief executive.

Public holidays

A chief executive may require the whole or a of a department to remain open in the public interest for the whole or portion of a public holide, to be observed or a special holiday under the *Holidays Act* 1983 and may require the attendance of my runner rvice employee for this purpose.
